Jon Galbraith is a twenty-six year veteran of the Georgia Department of Revenue. His career with the Revenue Department began in 1981 as a Tax Field Agent in the Atlanta Regional Office. Jon advanced to an auditor's position, Tax Field Agent Supervisor and Interim Regional Manager during Amnesty serving in that capacity until March 1993; appointed as the first Sales & Use Tax Conferee, and later appointed as the Administrative Specialist Senior for sales and use tax administration. Upon the creation of the Tax Law and Policy Section, Jon's title was renamed Tax Policy Analyst, Senior.

Jon attended Oglethorpe University and majored in Business Administration.
