Our speaker before dinner is George A. Reynolds is Senior Deputy Commissioner of the Georgia Department of Banking & Finance (DBF). George joined the DBF in 1979 as an Assistant Financial Examiner in the Northeast District and has previously served as Assistant Deputy Commissioner, District Director of the Albany & Valdosta Field offices and Deputy Commissioner for Supervision. He was promoted to Senior Deputy Commissioner in July of 2003. George received a BBA degree from Emory University, a Masters of Accountancy degree from Georgia State University and is a graduate of the Graduate School of Banking at the University of Wisconsin, Madison.

He is a Certified Public Accountant and member of the American Institute of Certified Public Accountants, a Certified Financial Examiner, a Certified Examinations Manager (CSBS) and a Certified State Credit Union Examination Supervisor (NASCUS). He has served on the Board of Governors and Executive Committee of the Society of Financial Examiners, has served on several committees for the Conference of State Bank Supervisors and is a member of the Board of Trustees for the Education Foundation for State Bank Supervisors (EFSBS).
