President's Message

I would like to thank everyone who came to the May meeting for making it a lively discussion about cash balance pension plans. I think everyone came away with a new understanding of this type of plan. For those of you who missed it, the outline and PowerPoint presentation are available on our web site.

At our June meeting, we will be having two special functions. First, the incoming officers and Board members will be sworn in. Second, we will be giving out our chapter scholarships to 10 deserving students. Instead of our normal speaker, we will have a panel discussion, similar to last year's presentation, to give the students a feel for what the profession has to offer and how to make themselves more attractive to prospective employers.

May 15 was the GSCPA Spring Council meeting in Chattanooga. In attendance from our chapter were Jennifer Birtz, Marian Macleod-Elliott, Martha O'Brien, Ellen Sweatt, Dick Negus, Bob Prator, and myself.

I was nominated to serve on the Board of Directors for a 2-year term 2009-2011. Bob Prator, incoming GSCPA President, has been nominated to the AICPA Council to serve a 3-year term 2009-2012. In addition, chapter members Dick Negus and Jennifer Birtz were nominated to serve 2-year terms as at-large representatives to the Council for 2009-2011. Elections will be held at the annual meeting, which is part of the annual convention.

The Council approved the proposed bylaws amendments with one modification. After much discussion, the Council voted to further amend the bylaws to require Council approval of any new GSCPA membership requirements in the Associate Member category. Meaning that before the GSCPA can allow "other accounting/finance professionals as defined by the Board of Directors," the Council must approve the definition of this group. All GSCPA members will be asked to approve or disapprove the proposed bylaws amendments soon.

The Council discussed the new 2009-2010 GSCPA budget at length and ratified it. The budget provides for a \$10 increase in fellow and associate members' dues. Additionally, the budget reassesses the way the GSCPA will fund chapters. Chapters with net assets of \$10,000 or more will not receive the \$3,000 annual funding provided in the past. The GSCPA has taken advantage of cost cutting opportunities and will continue to do so. It is also looking carefully at its offered programs and is seeking input from members about the value of the programs, including future CPE offerings and methods of presenting CPE.
