PART 1: IRS TAX EXAMINATIONS AND HOT ISSUES

Due to IRS issue-focused examinations, CPAs need to understand the types of returns selected for examination and ways to help clients survive an IRS audit with little or no change. As a result of issue-focused examinations, CPAs must understand what the high audit risk area issues are and what the IRS is focusing on when examining a return. Also, because tax-related identity theft is a common issue for many taxpayers, CPAs must understand the procedures necessary to resolve this matter for their clients.
