

# High School Honors Luncheon

The Georgia Society of CPAs (GSCPA) High School Outreach Task Force is pleased to present the eighth annual High School Honors Luncheon (HSHL). This luncheon recognizes top business and accounting students and shows them the exciting opportunities available in the accounting profession. It is also a chance for educators and guidance counselors to learn about the Georgia Society of CPAs and the many educational resources available.

The GSCPA High School Honors Luncheon will be held on Monday, January 11, 2010 at Maggiano's in Buckhead.
