Disruptive Technology?

Clayton Christensen in *The Innovator's Dilemma*

It initially costs more than the item it is initially seen as replacing

It doesn't perform as well as previous devices; innovation is not quite as good as the existing innovation.

Customers and market research did not show a great desire for the new innovation or device.

There was confusion about exactly what one would do with it, or how it fits into the existing market.

The initial market was small.

How does the iPad measure up?

It costs more. The iPad is compared with both the Amazon Kindle and netbook computers and is seen as too expensive in comparison.

Does not perform as well -- too heavy, missing important features, e.g. keyboard, SD slot, USB port, etc.

No one was asking for it. Previous tablet offerings have had limited success.

Why does anyone need it? It is unclear what the "killer app" will be for the iPad.

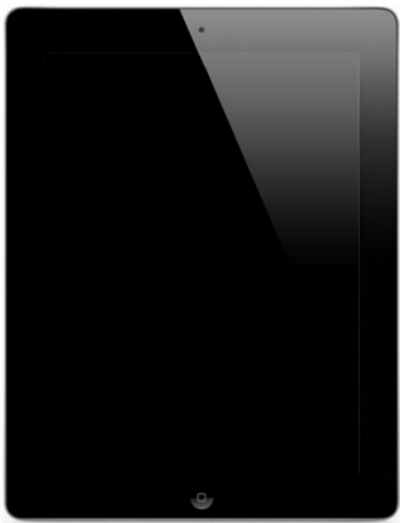
No one had ever had success selling "tablets" before.

No contest.



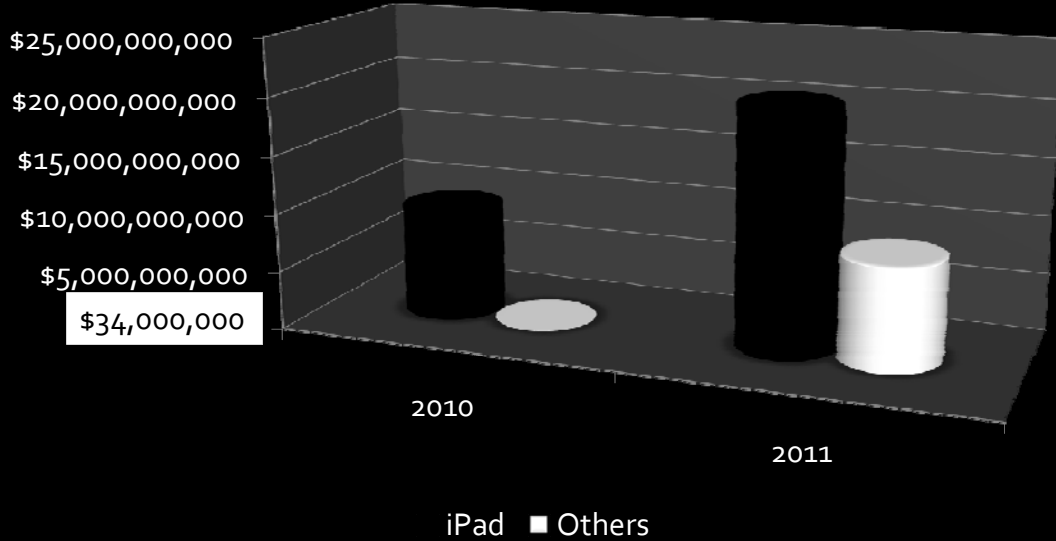

Wi-Fi only or 3G? Internal or MiFi?

- The **iPad 3G**'s all-in-one design is both a feature and a liability.
- No need to transport or charge 2 different devices.
- The MiFi's internet connection can be shared, while the standard iPad 3G is an island unto itself.
- MiFi has a battery life of 3 to 4 hours compared with the Wi-Fi iPad's 10 hours or the iPad 3G's 9 hours.
- The MiFi will turn into sleep mode when not in use.
- No need to be physically attached to the MiFi.
- Unlike the **iPad 3G**, the MiFi uses common replaceable batteries, so you can carry a spare or two and get more usable 3G time than with the **iPad** alone.

Verizon Plan:



- The Verizon plans are:
 - 1 GB for \$20
 - 3 GB for \$35
 - 5 GB for \$50.
 - 10 GB for \$80
- No contract
 - Pay for 30 days of service, but you can put the service on hiatus and pay for another 30 days whenever you need it
 - Modify directly from the device ---up / down / off / on.

AT&T Plan:



- \$15 per month for 250 MB 2 GB for \$25
- Go over 2 GB, you re-up for another 2 GB at \$25
- No contract
- Pay for 30 days of service, but you can put the service on hiatus and pay for another 30 days whenever you need it

Verizon or AT&T?



- Verizon has the same initial cost for hardware as AT&T
- The Verizon Wi-Fi only iPad is CDMA and won't be as easy to use overseas
- Light internet users don't have a 250 MB data option.
- Heavy users benefit from Verizon's data plans.
- Conclusion:
 - With more data flexibility, Verizon's alternative is a compelling value.
 - For those users who want to stream tons of multimedia content, Verizon's is the better alternative.
 - For very light users who only need one connected mobile device, AT&T is likely a better value.

Security

Control, Protection and Security Issues

1. Deploying a **device passcode** prevents unauthorized users from accessing data or otherwise gaining access to the device.
2. iPad allows timeout periods, passcode strength, and how often the passcode must be changed.
3. Microsoft Exchange ActiveSync passcode policies supported include:
 - Enforce password on device
 - Minimum password length
 - Maximum failed password attempts
 - Numbers and letters both required
 - Inactivity time in minutes
 - Simple password allowed or prohibited
 - Password expiration
 - Password history
 - Policy refresh interval
 - Minimum number of complex characters in a password

Policy enforcement

The policies described can be set on iPad in two ways.

- If the device is configured to access a Microsoft Exchange account, the Exchange ActiveSync policies are pushed to the device over the air, enabling policies to be enforced and updated without any action by the user.
- Policies can also be distributed as part of a configuration profile for users to install. A profile can be defined so that deleting the profile is possible only with an administrative password. Alternatively, you can define the profile so that it's locked to the device and cannot be removed without completely erasing all of the device contents.

Device restrictions – is IT in control?

- Device restrictions determine which iPad features your users can access. You can control actions such as application installations.
- Device restrictions allow you to appropriately configure the device and set permissions for employees to use the device in ways that are consistent with your firm practices.
- Restrictions are enforced using a configuration profile, or they can be manually configured on each device.
- The iTunes desktop application can also be configured and controlled by IT. This includes disabling access to explicit content, defining which network services users can access within iTunes, and whether new software updates are available for them to install.

Data Protection

- **Encryption**
 - 256-bit AES encoding hardware-based is always enabled and cannot be disabled by users.
 - Data backed up in iTunes can be encrypted.
 - When an encrypted configuration profile is stored on the user's device, this capability is enforced automatically. Developers can encrypt data within their own applications.
- **Remote wipe**
 - iPad supports remote wipe. If a device is lost the owner can issue a remote wipe command that removes all data and deactivates the device.
- **Local wipe**
 - Devices can also be configured to automatically initiate a local wipe after several failed passcode attempts. By default, iPad will automatically wipe the device after 10 failed passcode attempts..

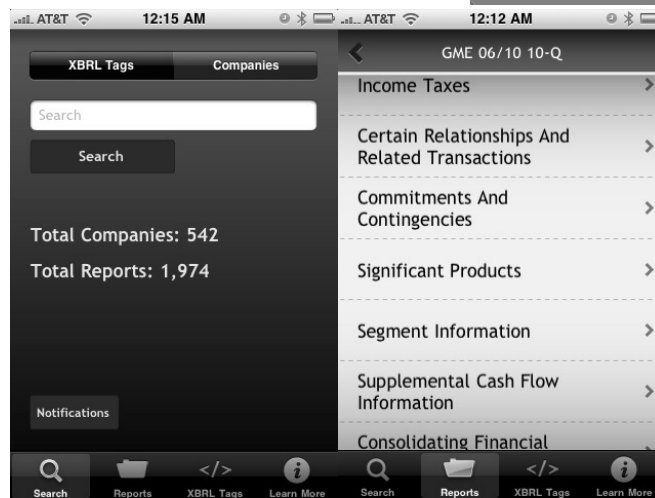

The Brix Project (By XBRL US)

- Build reports of corporate filings, (e.g. balance sheet) and view contents as individually tagged facts.
- Find the frequency of tag usage along with definition and list of companies using that tag.
- Get alerts for a specific company or tag.

Find My iPad



- Free
- If your device is lost or stolen, you have the following options:
 - **Display Message or Play Sound:** You can type out a message about where you can be reached for returning your device. And/or you can have a sound played on your device. The message will appear or the sound will play even if your device is locked or set to mute.
 - You can **send a new passcode** to your device which remotely locks it
 - Permanently delete all the data, restoring the device to factory settings. Note the instructions: *"Once wiped, your device will no longer be able to display messages or be located"*.
- In most cases, the Find My iPhone service has located my iPad in less than a minute, but one occasion it took almost ten minutes. But out of the handful of times I've used it, it's never failed to locate the device.

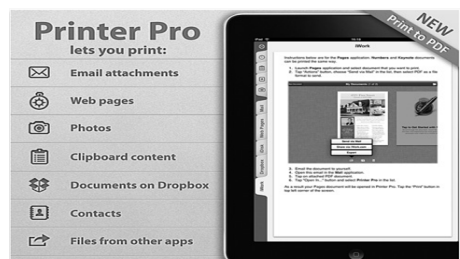

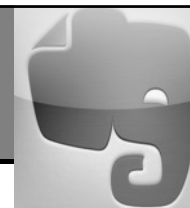

- A "note" can be a piece of text, a full webpage or webpage excerpt, a photograph, a voice memo, or a handwritten "ink" note.
- Notes can also have file attachments.
- Notes can then be sorted into folders, tagged, annotated, edited, given comments, and searched.
- Notes automatically synchronized with the Evernote server, letting a user access and edit notes across multiple machines and O/S's, but still view, input and edit data when an internet connection is not available.
- Users can access their note archive via a web interface, with more limited functionality.

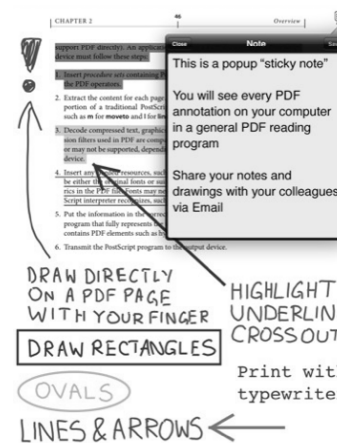
