Intersection Highway 74 & 54

Get on 74 north, and travel for 3 miles

At the 3rd stoplight, turn RIGHT onto Dogwood Trail

Take first LEFT onto Glendalough Court

***From Newnan***

Take 34 through Peachtree City, take a LEFT on Hwy 74, go about 3 miles on 74 N, take a RIGHT onto Dogwood Trail, take an immediate LEFT onto Glendalough Ct., follow the road to the entrance of Glendalough Manor.

OR

Take 85 N, Take exit 56 Palmetto/Tyrone, Take a RIGHT off the exit (Tyrone Rd.), Travel about 2 miles until you come to a stop sign, Go straight through the stop sign and cross over railroad tracks, At the stop light take a RIGHT onto Joel Cowen Pkwy (Hwy 74). Take a LEFT at the next Stop light (Dogwood Trail), take an immediate LEFT onto Glendalough Ct.
